### Where They Started...

- 64% diagnosed mental health illness
- 66% two or more chronic conditions
- Loss of identity
- Perceive low resilience
- "If you've not been through it you just won't get it"

Long and very chequered history of research done ON disabled communities by non-disabled researchers for own gain (Fitzgerald, 2009)

Previous experiences of being made to do research they didn't really want to do as they did not have power to say no

Experiences of commissioned officers with degrees "lording over" members without degrees

We do not come to research as empty vessels, and neither do participants


- "You guys are seriously part of the team"

### Vulnerable Observers (Baher, 1996, 2022)

- Researcher vulnerability essential part of ethnography
- Affect and are affected emotionally, physically, ontologically

"...vulnerability doesn't mean that anything personal goes. The exposure of the self as a spectator has to take us somewhere we couldn't otherwise get to. It has got to be essential to the argument, not a decorative flourish, not exposure for its own sake..."

(p.14)



## Sharing Our Transparent Selves

 Vulnerability is a shared ontological condition – to ask participants to be vulnerable, we must be vulnerable ourselves (Rodgers et al., 2012)

### (Re)Interpreting 'Ethical' Rules

 "When we privilege highly bureaucratized protocols over human-to-human communications, we risk an erasure of humanity of everyone involved in research" (Lake & Hartmann, 2023)
