1. GENERAL OVERVIEW

Statement of aims

The Centre for Rural Research (CRR) has five main aims:

- to supply an independent consultancy service for quality rural research;
- to develop national and international research interests whilst maintaining a local focus on Worcestershire and neighbouring counties;
- to disseminate knowledge in an accessible manner to the wider public including policy-makers, countryside managers, those in education, voluntary organisations and people living and working in the countryside;
- to contribute to the development of geography and rural studies;
- to assist in the strategic delivery of the mission of the University of Worcester in the key areas of 'research' and 'contribution to the region'.

Summary of Position

This report covers the activities of the CRR from 1st September 2008 until 31st August 2009. In summary, this has been a relatively quiet year. Three major projects were undertaken in 2008/9 and one completed after being commissioned in the previous year. CRR's financial position remains healthy at the end of the period. As always, CRR delivered successfully client contract work whilst the principal researchers (NE and DS) continued to commit themselves fully to teaching and administrative duties. CRR was delighted welcome Alan Dixon on board as a full member of the Research Centre. His activities in the rural geography of developing countries will strengthen considerably CRR's international dimension.

Work continues to be commissioned by a variety of rural organisations based on CRR's reputation for quality in research. CRR remains highly active as a University of Worcester research centre, continuing to raise the research profile of the institution. It was identified as a specialist area of research within the Geography Unit of Assessment submission to the 2008 Research Assessment Exercise and its excellence in rural geography identified in the feedback from the Geography Panel. In total, two new research projects were initiated in the period of the report. The year was notable in that it represents the first since 2000 in which no dedicated full-time research assistants were employed. Katie Milburn left in the summer of 2008 to take up a permanent post with a county wildlife trust. CRR staff for 2008/9 therefore comprised academic staff, Peter Carruthers as CRR Senior Research Fellow and two part-time researchers/casuals. CRR continues to make very tangible contributions to raising the profile of the University





of Worcester internationally in the world of research and within the regional community of the West Midlands.

3. POSTGRADUATE RESEARCH STUDENTS
